PE Off-Site Activity Programme

The PE Department are fortunate to be able to offer a variety of off-site sporting activities for year 11 in their PE lessons. We firmly believe that this will support them with their well-being over what can be a stressful year with external examinations and extra revision sessions.

Off-site activities will take place at Cygnets Leisure Centre and will include the following sports:

- Squash.
- Use of various fitness rooms with a fitness instructor.
- Table tennis.
- Access to indoor playing areas for net & ball games.
