Consent form for Parents of Students in years 7-11. Changes to Data Protection Law – General Data Protection Regulation (GDPR)

As I am sure you are aware, from 25 May 2018, the rules around data protection have changed. The 'General Data Protection Regulation' (GDPR) will change how we can use your personal data and keep it safe, and will also strengthen your rights over your own data.

The point of this is to make sure sensitive or private information about yourselves and our students stays safe. Whilst it is similar to the current Data Protection Act in many ways, there are a few differences, so we need to make a few changes at the school in order to ensure we remain compliant.

One of these changes is that we have updated our privacy notice which is available to read on the School Website, www.ntc.kent.sch.uk

At Northfleet Technology College, we use information about our students in a number of different ways. As part of our work to comply with the GDPR, we are re-seeking consent for various data such as the use of our student's photographs or videos on the school website, internal displays or other school materials.

If you are happy for us to use information in the ways we list below, we require you to tick and sign all the data you are in agreement with.

If you are **not** happy for us to use information in the ways we list below, that's no problem – we will accommodate your preferences.

*Please note that for any item of data listed below, you do not tick against, we will assume that you or our students **DO NOT** wish the data to be collected and used for the reason shown. This will result in our student being asked to not participate in certain activities/events (e.g. sporting team photos).*

Similarly, if you or our students change your mind, you can withdraw permission at any time and please let us know by emailing our Data Protection Officer, Mr A Riddle, on dpo@ntc.kent.sch.uk.
